Britain has finally done what it has been threatening to do for years. After being inundated with facts, fictions, arguments and pleas, 51.9 percent of Brits took a look at the runaway train of integration that is the EU and said: "No thank you".

Aside from our re-imagined relationship with the EU, here are a few aspects of the long-anticipated referendum that will have lasting consequences for the country.

1) Turnout was 72.2 percent – the highest since 1992. this is a huge success for democracy.

We are no longer a mindlessly predictably electorate, and politicians need to wake up to that.

We English Democrats need to wake up to an electorate who want their English identity back.

2) The demographic difference between the old and the young matters. Millennials have it better than any other generation in history.

But that does not change the sense of rejection and distance felt as politicians in Westminster repeatedly cater to the old over the young. They will also have the most access to benefits that come with Leaving – less regulation and more freedom to shape their country's future.

England must be allowed to determine her own future and all ages must be involved.

3) Scotland, Northern Ireland, London, and Bristol voted strongly for Remain. The rest of the country, including most of Wales, backed Leave. It is difficult to imagine now how the two sides can be reconciled.

But reconcile they must. Britain has great challenges ahead.

We have a newly engaged electorate, and politicians are finally listening. And new opportunities beckon across the world, from the US to China to Australia.

Britain has a clean slate – now we must decide what we will do with it.

Industry and Trade Deals

UK Goods exports to:

Guyana were worth \$36.5 million in 2015.

Botswana were worth \$32.17 million in 2015.

Barbados were worth \$54.74 million in 2015.

Congo were worth \$225 million in 2015.

Kuwait were worth \$884.87 million in 2015.

Hong Kong were worth \$10.138 billion in 2015.

UK Pork exports continue to increase with volumes up 26% on the previous year.

Talks are currently underway to formalise trade deals with the following countries: India, USA, China, Australia, Russia etc.

Jobs and Investment

Manchester Science partnerships to fund £60 million expansion of biomedical centre of excellence Citylabs creating 750 jobs.

GSK to invest £550 m in Stevenage and further £275 m in plant across the UK.

Hammond pledges to match EU funding of £4bn a year for thousands of British business and organisations

Amazon is to create 500 new permanent jobs in the UK.

UK Steel fabricator **SBu Fabrication** is to take on bigger projects after gaining prestigious quality standard.

Manchester headquartered big data analytics company **Hello Soda** expands with US launch in Austin Texas

UK is still the biggest foreign investor in the US at \$449 billion a year and supports over 1 million jobs there.

UK model railway business **Hatton** sees sales soar post-Brexit vote and increases staff numbers by 11%.

Sky and **Channel 4** make joint investment to sell more British TV abroad.

Travel and Tourism

Number of foreign visitors to Britain jumps 18% in the month after the Brexit vote.

Miscellaneous

Economic growth in the **Eurozone** slowed in the second quarter to +0.3%. Half the growth seen in the first 3 months of the year.

UK growth was 0.6% in same period.

FTSE 100 index breaks through 6,900 and FTSE 250 Index breaks through 17,900

ONS data reveal that retail sales jumped 1.4% in July.

Anyone who thinks that UK membership of the EU is the norm should consider this: the UK has existed for 309 years, but they have been in the EU for 43.

Editorial

Philip Hammond, the UK Chancellor, just announced that the UK would match any EU programs if leaving the European Union would entail their loss.

This includes programs such as the Common Agricultural Policy (CAP) and Common Fisheries Policy (CFP) subsidies for Britain's farmers, European research funding, and some of the structural assistance funding.

There is nothing wrong with this suggestion.

The UK is sovereign, and can make any announcement it sees fit to make. And of course, funding scientific research is exactly what government research and development policy should promote.

Direct transfers to impoverished places in the country is also an uncontroversial policy choice, depending of course on what that payment is used for.

The government should be commended for giving this level of stability at least until 2020 which is about the time that any negotiation on withdrawal from the EU would be concluded.

The UK will suffer uncertainty for a minimal period.

As Britain sails forward into the choppy waters ahead, we need to keep our negotiating options as open as they can be. Reserving our ability to present to the world a face which is open to the world will be a key part in securing safe passage towards a place where Britain is at the centre of a trading network.

What Can You do to Make sure Article 50 is filed promptly?

Actions

Write to your MP. It doesn't matter if your MP voted Remain they need to understand how the public feel. Many of them have tried to dismiss Leave Voters as less intelligent.

Complain

Be Aware

Be sure to keep up to date with the facts. Brexit will be used to blame for many events that happen over the next few months. This of course is not true. Be prepared to counter this if you know better.

Tell others

There are still a lot of myths about what leaving the EU (not Europe) means. House prices will fall (good news if you are a first time buyer); foreign travel will be impossible in Europe (why??); Budget airlines will be more expensive; food will become more expensive; trade with other countries will not happen; other EU countries will be taking it out on us etc. We need to be prepared to not fall into the trap of allowing such myths to continue.
